2. the route(s) they plan to establish at Osijek Airport,
3. the planned operation period (year-round/seasonal) and the total duration of the contract,
4. the number of weekly rotations on each route,
5. the aircraft type and/or an indication of the minimum number of seats to be provided on each flight,
6. forecasts of the total number of arriving and the total number of departing passengers on each route during the term of the contract,
7. advertising channels to ensure the promotion of the route(s),
8. the type and amounts of incentives they require,
9. other conditions for establishing the route, if any,
10. whether there is interest in establishing a base at Osijek Airport.

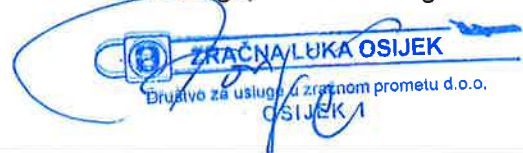
